Dear Parent or Guardian:

**IGCSE Examination Fee**

Non-Chinese speaking (NCS) school candidates who have satisfied the **specified circumstances** as stated in the Education Bureau Circular No. 19/2012 (the Circular) will, during their full-time senior secondary school years, be eligible for the “subsidised examination fee” for:

- (a) **up to two entries** for any of the following examinations: the GCSE (Chinese) Examination, the IGCSE (Chinese) Examination and the GCE AS-Level (Chinese) Examination; and
- (b) **up to two entries** for the GCE A-Level (Chinese) Examination.

The Education Bureau has made arrangements with the HKEAA to reduce the examination fee for eligible NCS school candidates to a level on par with that of the Hong Kong Diploma of Secondary Education Examination (HKDSE) (Chinese Language). The examination fee of HKDSE is subject to annual review by the HKEAA.

Eligible NCS school candidates entering for the 2026 Pearson Edexcel GCE A-Level / IGCSE / GCSE and Cambridge IGCSE Chinese Examinations shall pay the “subsidised examination fee” (i.e. \$777) on par with that of the 2026 HKDSE (Chinese Language) Examination while the Education Bureau will top up the difference in fees between this examination and the “subsidised examination fee” payable by school candidates. Only **CASH** is accepted.

\*For students under the CSSA Scheme, a receipt will be issued in around July 2026. Students can claim a reimbursement from the Social Welfare Department using that receipt.
