Seasonal Influenza Vaccination School Outreach Programme

The Department of Health will arrange a vaccination team (under the Public-Private Partnership Scheme) to conduct on-site seasonal influenza vaccination (GSK Injectable Inactivated Vaccine) for students who have consented to participate. Details are as follows:

Date:	13 October 2026 (Tuesday)
Time & Venue:	At school hall, during normal school hours
Target:	Secondary 1 to Secondary 6 students
Format:	On-site administration by healthcare personnel (Medical Provider: Swindon Medical)
Vaccine Manufacturer:	GSK (GlaxoSmithKline)
Provision Mode:	Doctor's Vaccine Provision Mode
Vaccine Type:	Injectable (Inactivated Seasonal Influenza Vaccine)
Fee:	Free of charge (Subsidised by the Department of Health)

Consent Form Submission Arrangements

Our school adopts electronic consent forms (e-Consent). All parents are requested to complete and submit the form on or before **8 September 2026 (Tuesday)**. Details are as follows:

2. **Paper Consent / Refusal Form (Mandatory paper submission under the following circumstances):**
- **Students aged 18 or above:** Students who reach the age of 18 on or before 13 October 2026 **must** complete a paper consent form.
 - **Non-consent cases:** Parents who choose **not** to allow their child to be vaccinated at school **must** complete a paper refusal form to indicate their decision.
 - *Note: Class teachers will distribute paper forms to students in need. Please complete the form in black or blue ballpoint pen and return it to the class teacher on or before 8 September 2026.*

Arrangements and Precautions on Vaccination Day

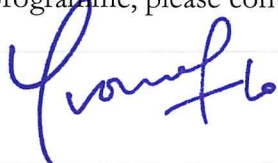
The vaccination team will serve at school on 13 October 2026. Parents who have consented please remind your child of the following on that day:

1. Vaccination Card: Bring the Seasonal Influenza Vaccination Card (if any).
2. Proper Diet: Have a proper breakfast in the morning; do not fast.
3. Appropriate Attire: Wear clothes or school uniform that allow easy exposure of the upper arm for injection.
4. Special Notice: Please inform the school immediately if your child has received the 2026/27 seasonal influenza vaccine on or after 1 September 2026, or if you have any queries. (Vaccination will be conducted punctually at scheduled times; latecomers will not be accommodated.)

Notes for Parents and Health Guidelines

1. Voluntary Basis: Vaccination is entirely voluntary. Parents may opt out of the school scheme and arrange vaccination at other medical institutions independently.
2. Health Assessment: Students with a history of severe allergic reactions to any vaccine component or previous flu vaccinations are not suitable for this activity. Please consult your family doctor prior to vaccination if you have any doubts regarding your child's suitability (e.g., egg allergies).
3. No Make-up Session: No make-up vaccination sessions will be provided at school for students who opt out or are absent on the vaccination day. Parents will need to bring their child to private clinics participating in the "Vaccination Subsidy Scheme" independently.
4. Personal Data & Records: Students are not required to submit physical immunisation record cards. Completing and signing the consent form signifies agreement to provide the student's personal data to the Government or authorised third parties.
